2. A licence to GIS247.com is granted on either a 12 or 24 month basis from the date indicated on this order form (provided full payment has been made) or from a later date agreed in writing.

3. Your "Set User" licence will permit the agreed number of user accounts to be created at GIS247.com. These user accounts must not be exchanged or shared between users. Additional user accounts can be created above the initial maximum of the licence purchased upon payment of the appropriate additional user upgrade fee as agreed in writing with Sological Solutions. The additional user upgrade fee is payable in full and not based on a pro-rata calculation for the licence period. The addition of any users will not extend the duration of the initial licence period.
4. GIS247.com is a trading name of Sological Solutions. You agree that Sological Solutions can use your organizations name on any of its marketing, publicity and other promotional material unless you state otherwise on the order form.
